DEFINITION

In this Release Agreement, the term “Activities” shall include all activities, events and services provided, arranged, organized, conducted, sponsored, hosted, or authorized by the Releasees relating to its Wilderness Explorers and Summer Sampler Programs and Camps, including without limitation: field and gym games including gaga ball, and nine-square in the air; hiking on and off site; playing with and discovering mud, water, and natural materials; loose parts play in makers spaces; camouflage games; as well as certain specific activities including:

- For Wilderness Explorers Programs: Friday finale activities such as tag and relay race games; discovering tools such as hammers, hand drills, and potato peelers; crafts with natural and man-made materials; play on uneven and/or dynamic surfaces including natural playgrounds;
- For Summer Sampler Programs: activities such as soccer, mission impossible, relay races, kickball, pickleball, dodgeball, and omnikin ball; and

all other such activities, events and services in any way connected with or related to the Releasees, or travel to/from and presence at any Facilities (defined below).

ASSUMPTION OF RISKS

I am aware that the Participant’s participation in the Wilderness Explorers & Summer Sampler Programs and Activities involves many risks, dangers and hazards including, but not limited to: hiking on and off-site; collision or impact with equipment, other persons, or natural or man-made obstacles; unwanted contact with projectile objects or equipment; physical contact, such as body contact or physical aggression from other participants; cuts and abrasions from equipment; improper use or failure of equipment; falling off equipment or from heights; failure to properly adjust or fasten equipment; inadequate equipment; power, mechanical or structural failure of facilities, terrain, or equipment; in adequate course conditions; changing weather conditions or exposure to extreme weather conditions; slips, trips, falls or loss of balance; the

failure to act safely or within one’s own ability or to stay within designated areas; difficulty or inability to control one’s speed or direction; sudden stops or changes in direction; failure to slow or stop in designated areas; becoming lost or separated from the guides or instructors or other participants; variable or difficult conditions; exposed rock, earth, ice, trees, tree stumps, forest deadfall, and other natural objects; fire; hot cooking equipment; changes or variations in terrain, such as holes, depressions, loose gravel, rocks, mud, creeks, bumps, berms, steep or slippery sections, cracks, ruts, etc.; negligence of other persons; drowning (when near, on, or in water); encounters with domestic or wild animals; insect bites or stings; a medical condition, whether known or unknown; allergic reactions; choking; disorientation; fatigue; overexertion; negligent first aid; infectious disease contracted through viruses, bacteria, parasites, and fungi which may be transmitted through direct or indirect contact; and NEGLIGENCE ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES THE FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT THE PARTICIPANT FROM OR WARN THE PARTICIPANT OF THE RISKS, DANGERS, AND HAZARDS OF THE WILDERNESS EXPLORERS & SUMMER SAMPLER PROGRAMS AND ACTIVITIES. I am also aware that the risks, dangers, and hazards of the Wilderness Explorers & Summer Sampler Programs and Activities exist throughout the Facilities and surrounding areas and that many hazards are unmarked.

I AM AWARE OF, FREELY ACCEPT AND FULLY ASSUME ALL OF THE RISKS, DANGERS, AND HAZARDS ASSOCIATED WITH THE WILDERNESS EXPLORERS & SUMMER SAMPLER PROGRAMS AND ACTIVITIES AND THE USE OF THE FACILITIES, AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE, OR LOSS RESULTING THEREFROM.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Releasees allowing the Participant to participate in the Wilderness Explorers & Summer Sampler Programs and Activities and permitting the Participant’s use of their equipment, trails, hill, restaurants, day lodge, parking, access roads and other facilities, which facilities shall include any and all areas and premises where the Wilderness Explorers and Summer Sampler Programs and Activities are provided by the Releasees, whether owned by the Releasees or not (collectively, the “Facilities”), I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES, and TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer, or that my next of kin may suffer, as a result of my participation in the Wilderness Explorers & Summer Sampler Programs and Activities or my use of or presence on/at the Facilities, DUE TO ANY CAUSE WHATSOEVER, INCLUDING NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS’ LIABILITY ACT, RSA 2000, c O-4, ON THE PART OF THE RELEASEES. I UNDERSTAND THAT NEGLIGENCE INCLUDES FAILURE ON THE PART OF THE RELEASEES TO TAKE REASONABLE STEPS TO SAFEGUARD OR PROTECT ME FROM, OR WARN ME OF, THE RISKS, DANGERS, AND HAZARDS OF THE WILDERNESS EXPLORERS & SUMMER SAMPLER PROGRAMS AND ACTIVITIES OR USING THE FACILITIES;

- 2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any property damage, loss, or personal injury to any third party resulting from my participation in the Wilderness Explorers & Summer Sampler Programs and Activities, or my use of or presence on/at the Facilities;
3. This Release Agreement shall be effective and binding upon my heirs, next of kin, executors, administrators, assigns and representatives in the event of my death or incapacity;
4. This Release Agreement and any rights, duties, and obligations as between the parties to this Release Agreement shall be governed by and interpreted solely in accordance with the laws of Alberta and no other jurisdiction;
5. Any litigation involving the parties to this Release Agreement shall be brought solely within Alberta and shall be within the exclusive jurisdiction of the Courts of Alberta; and
6. If any provision of this Release Agreement is held by a Court to be unenforceable, then such provision will be modified to reflect the Participant and Releasees’ intention. All remaining provisions of this Release Agreement shall remain in full force and effect as drafted.

In entering into this Release Agreement, I am not relying upon any oral or written representations or statements made by the Releasees with respect to the safety of the Wilderness Explorers & Summer Sampler Programs and Activities other than what is set forth in this Release Agreement.

I HAVE READ THIS RELEASE AGREEMENT AND I AM AWARE THAT, BY SIGNING THIS RELEASE AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, ASSIGNS AND REPRESENTATIVES MAY HAVE AGAINST THE RELEASEES, INCLUDING THEIR RIGHT TO SUE. I ACKNOWLEDGE THAT I AM SIGNING THIS RELEASE AGREEMENT FREELY AND VOLUNTARILY AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY.
